

## The Moys of New York and Shanghai

#### The most extraordinary family you've never heard of.

Born to Chinese immigrant parents, the Moy siblings grew up in an America that questioned their citizenship and denied their equality. Sophisticated and self-consciously modern, they challenged limitations and stereotypes in the United States and sought new opportunities in China's tumultuous republic. Sometimes the risks they took paid off, but their occasional recklessness also led to infidelity, divorce, bankruptcy, and worse. Those in China faced pressure to collaborate with Japanese occupiers, making choices that had serious consequences for their siblings in the United States.

Charlotte Brooks's gripping tale follows the family back and forth across the Pacific and through two world wars, China's Nationalist and Communist revolutions, and the Cold War-events that the siblings and their spouses helped shape. The Moys' incredible story offers a kaleidoscopic view of an entire generation's struggle for acceptance and belonging.

## **American Peril**

The Violent History of Anti-Asian Racism Scott Kurashige

This probing account shines a new light on the problem of anti-Asian violence and inspires us to build lasting solidarity.

During the COVID-19 pandemic, racist demagoguery fomented a campaign of terror against Asian Americans. But these attacks were part of a much longer pattern that made anti-Asian racism integral to the outbreak of white supremacist, misogynist, and colonial violence across 175 years of U.S. history. Written in the radical spirit of Howard Zinn, American Peril represents the culmination of thirty-five years of study and activism by award-winning scholar Scott Kurashige.

From the lynching of Asian immigrants during the exclusion era to the U.S. military's slaughter of Asian civilians, the book connects domestic and global events that have been erased from the official record. Going beyond victimhood, it traces the rise of Asian American community protest and activism in response to the 1982 murder of Vincent Chin and other overlooked tragedies. While many have worked to legislate and prosecute hate crimes, Kurashige argues that hope lies in grassroots activism for multiracial solidarity.

Scott Kurashige is a distinguished nonprofit leader, educator, writer, and activist whose work spans over 35 years in combating anti-Asian violence. His work is rooted in transformational leadership with an intersectional focus on race, urbanism, and equity.

A gifted public scholar and organizer, Kurashige has bridged academic research with grassroots movements, especially among Black and Asian American communities in Detroit and Los Angeles. He is the author of four books and has delivered more than 150 lectures for universities, museums, and civic organizations. His work has been featured in *The New York Times, Los Angeles Times*, CNN, MSNBC, NPR, and dozens of other outlets.



### **Partnership with Grace Lee Boggs**

Kurashige began his collaboration with legendary activist and movement-builder Grace Lee Boggs (1915–2015) in 1998. Together they co-authored *The Next American Revolution: Sustainable Activism for the Twenty-First Century* (2011), published by University of California Press. The book draws on Boggs's seven decades of activist experience and commitment to critical thinking to redefine "revolution" for our times. It has become a touchstone for organizers, educators, and scholars.

Today, Kurashige carries her legacy forward as President and Literary Executor of the James and Grace Lee Boggs Foundation, working to share the vision of James and Grace Lee Boggs with current and future generations of changemakers.

Rolling Stone's first decade was truly rock 'n' roll: chaotic, wild, and unpredictable. ## a conversation with Peter Richardson

#### What is your history with Rolling Stone?

I started reading *Rolling Stone* as a teenager in the 1970s. The music and film coverage were right up my alley, and I was primed for Gonzo journalism. During that time, I also listened to FM radio, which rejected the Top 40 format and felt a lot hipper. The Vietnam debacle was over, and Watergate was a fresh memory. *Rolling Stone's* iconoclasm and irreverence were just right for me. Or maybe I should say they helped shape the "me" that was still a work in progress.

#### When did you become interested in the inner workings of the magazine?

It started when I was writing a book about Ramparts magazine. Ralph Gleason and Jann Wenner worked there right before they co-founded *Rolling Stone*.

I wanted to write more about the early days of *Rolling Stone*, so I asked Jann if he would support that. For me, that support included letting me see the magazine's papers, which were stored in a New Jersey warehouse. Jann helped make that happen. That material helped me understand the inner workings of the magazine and confirmed some of my hunches about its early days in San Francisco.

## Your new book, *Brand New Beat*, focuses on the first 10 years *Rolling Stone* based in San Francisco. What is it about its history in the Bay Area that makes it so unique and important?


You can't really understand the magazine's success if you don't understand its roots, especially the Free Speech Movement and the San Francisco counterculture. That said, the magazine's relationship with the counterculture was complex. Most of its biggest stories were about the hippie community's catastrophes. *Rolling Stone* was always more than a rock magazine. There were big doses of sex,drugs, and rock and roll, but also critiques of militarism, materialism, environmental rapacity, and spiritual emptiness.

#### Can you name a particular article or writer from the period you cover that stands out?

Robin Green's profile of David Cassidy.

Cassidy was a teen idol with licensing deals and a huge fan club, but he wanted to be taken seriously as an artist. Annie Leibovitz suggested that posing nude would help him with that. Green's profile opened with Cassidy high, drunk, and sitting in a limousine outside a Manhattan nightclub. The title, "Naked Lunch Box," was a stroke of genius. It was the beginning of the end for David Cassidy.

The story is emblematic in many ways. It made fun of teen idols and, by implication, the teen magazines that created them. From the beginning, Jann and Ralph made sure that *Rolling Stone* wouldn't be mistaken for the teen magazines that preceded it. Instead, they helped create a brand new beat, the rock music beat, which my title echoes. "Naked Lunch Box" was a work of New Journalism and a sick burn, but it was also a way for *Rolling Stone* to define itself.

Dr. Larry Carbone began his animal work at the age of 14, at the local zoo. He went on to spend over 40 years as a veterinarian caring for animals in laboratories. He is the former Director of the Institutional Animal Care and Use Program at University of California, San Francisco, with board certifications in Animal Welfare and Laboratory Animal Medicine. His patients have ranged from mice to monkeys, woodchucks to dogs, and




many other creatures we put to service for medical progress.

Carbone's work on abolishing laboratory animal pain and developing more humane research has brought together allies as unlikely as the Humane Society, Northwest Foundation for Biomedical Research, Physicians' Committee for Responsible Medicine, and Genentech, Inc. An internationally sought-after speaker on veterinary medicine, bioethics and animal rights, his work has been covered in outlets such as *The New Yorker, The Atlantic,* the BBC, *Discover Magazine, Nature, Scientific American* and *Science*.

## **Dream Road to Pan America**

A Century in Pursuit of the World's Longest Highway

Shawn William Miller

#### An expansive and subversive history of the Pan-American Highway.


A century after the Pan-American Highway was first conceived, its story remains largely unknown—even to the hundreds of motorists who annually attempt the 30,000-kilometer drive from far northern Alaska to the tip of Tierra del Fuego. There is more to the highway, however, than the persistent allure of the open road. In *Dream Road to Pan America*, historian Shawn William Miller unveils a larger tale of lofty ideals and bedrock greed, romantic adventure and pragmatic diplomacy, immigrant desperation and Indigenous resistance.

This book journeys to the early 1920s when everyday Americans invented the idea of a road that would spread fraternity, democracy, and prosperity across the hemisphere. It looks at the commercial and geopolitical interests that shaped the highway—often with little concern for those living along its margins—and explains why the road became an escape route for millions of migrants rather than a corridor for tourists. Miller contends that the highway's troubled past points to an unresolved future, offering insights into the growing costs of continuing down well-worn paths.

## The Ultraview Effect

What We Can Learn from Astronauts about Awe, Humility, and Exploring the Unknown

Deana L. Weibel

#### What astronauts' extraordinary experiences of awe and humility teach us about humanity.

What is it like to stand in the shadow of Earth and the Moon and look out at the vastness of the Milky Way? To confront a view so grand it cannot be reproduced in a photo? These are the questions space anthropologist Deana L. Weibel asked as she interviewed astronauts and others in the space community. What they told her was not just surprising but also deeply moving. When gazing into star fields not fully visible from Earth, these astronauts experienced a profound sense of humility that fundamentally transformed their understanding of humanity. Welcome to the ultraview effect.

The ultraview effect expands on the classic "overview effect." Comparing spacefarers to religious pilgrims, Weibel suggests that this experience of deep humility is a generative reaction to awe, which inspires exploration and adventure. When facing the vastness of the universe, acknowledging our monumental ignorance is what drives our will to discover. A fascinating dive into science, cognition, and spirituality, The Ultraview Effect draws from astronauts' own accounts to make the case that continued human space exploration is not only a scientifically essential endeavor but also a culturally enriching one.



## **Making Care Work**

Why Our Economy Should Put People First

Nancy Folbre

## Lost Histories of Childbirth in Ancient Rome

Tara Mulder

A bold new history of women's health, brought to life through ancient women's stories of pregnancy and birth.

In the well-trod history of the Roman Empire, a pivotal moment has long gone unnoticed: It was in ancient Rome that medical men first set their sights on childbirth, the traditional domain of female midwives.

Taking us to the dawn of Western obstetrics, *A Womb of One's Own* offers a feminist account of how, against a long tradition of midwifery, male doctors began claiming authority in reproductive matters, with an emphasis on theoretical rather than practical knowledge. Their intrusion paved the way for the later criminalization of midwives as witches and abortionists and the cloaking of childbirth in secrecy and shame.

Yet communities of Roman women continued to help each other through the journey from preconception to postpartum, guided by their own experience and the expertise of midwives. Tara Mulder recovers stories of ancient women living and resisting as they sought autonomy over their bodies and their health. Recounting their experiences in vivid, intimate detail, she reveals how old our modern conflicts around birth truly are.

The ecological restoration movement that resulted has, for now, successfully preserved the Mono Lake Basin.



## Black Performance and the Kiss That Changed Film History

# Believing in Light after Darkness

Displacement and Refugee Resettlement Molly Fee

War, persecution, and climate change force people from their homes and across borders. Most refugees remain in difficult conditions in neighboring countries. The less than one percent of refugees offered resettlement to another country gain access to an alternative path forward with specialized supports and services traditionally understood as a program of integration and a solution to displacement.

By examining the complexities of refugees' lived experiences, Molly Fee's deeply humanistic ethnography reframes resettlement as a period of disruption and disorientation as newly arrived refugees navigate the rules and expectations of a new country. Rather than a solution that marks the end of displacement, resettlement becomes another uprooting for refugees who have already rebuilt their lives numerous times. *Believing in Light after Darkness* reveals how humanitarian solutions do not immediately resolve the conditions of displacement.



Immigration policy and enforcement practices in the United States now extend beyond the border to the country's interior, impacting the private lives of millions of undocumented and mixed-status families in new ways. *Sanctuary Making* traces this shift, showing how as enforcement has expanded and deepened, new "hot spots" have appeared across nontraditional sites such as neighborhoods, roads, worksites, hospitals, grocery stores, and homes. Undercurrents of fear, anxiety, and loss permeate the everyday lives of the families navigating these terrains of enforcement.

Carolina Valdivia reveals the emotional and material labor of young adults that often underpins families' sanctuary-making efforts—strategies to shield against the worst outcomes of enforcement. Many young adults are compelled to take on parental responsibilities and serve as a primary source of emotional support for family members while also brokering legal processes tied to their family's immigration cases. How might policymakers, organizers, educators, and the wider community better support these sanctuary-making efforts?



# The Welfare Assembly Line



Public Servants in the Suffering City Josh Seim

Despite claims that we live in a "post-welfare society," welfare offices remain vital not only for those who depend on them for benefits but also for those who depend on them for a paycheck. This book, a theory-driven case study of the Los Angeles County Department of Public Social Services, examines how welfare work has transformed to allow a department of just 14,000 to serve more than a third of the county.

Josh Seim argues that frontline workers at this agency—who are mostly Black and Brown women—have become increasingly proletarianized. Their work is defined less by their discretion and more by a lack of control over the productive process. This is enabled by a "welfare assembly line," where a high division of labor and heavy use of machinery resemble production regimes in factories and fast-food restaurants. With implications beyond the welfare office, *The Welfare Assembly Line* is a crucial addition to the broader national conversation about work, social policy, and poverty governance.



But thousands of cities worldwide are getting smaller—leaving behind vacant homes, abandoned factories, and oversized infrastructure. Shrinking cities pose a new problem for urban planners: how to manage the transition to a smaller population with a tool kit designed for expansion.

Urbanist Fernando Ortiz-Moya argues that instead of chasing regrowth, cities can embrace their smaller size and build on their unique character and history to enhance life for those who remain. From Pittsburgh to Manchester to Kitakyushu, We're Still Here contrasts official responses to shrinkage with spontaneous bottom-up actions led by traditionally marginalized residents. These stories show how decline becomes a springboard for social and physical (re)construction and justice-driven urbanism—revealing both the limits of pro-growth planning and the seeds of a new approach that he calls "(re)city-making." Far from a cautionary tale, this book makes a convincing case for the shrinking city as a laboratory for innovative, people-centered urban policy and collective empowerment.



How has European imperialism (re)made the world? How can we understand this long process and its consequences in ways that capture both the materiality and the subjectivity of political domination? Inspired by Frantz Fanon's insight that colonization entails the (re)crafting of geographic space, Landscaping Africa develops the concept of "landscaping" to explore the enduring global impact of European imperialism. Written by an Indigenous anthropologist, this book also demonstrates how Indigenous peoples, in Africa and beyond, are building upon and tearing apart European colonial projects. Michael C. Lambert probes three cases of landscaping involving the West African nation of Senegal: the forging of an international border between Senegal and Mauritania, the imposition of rural-urban distinctions, and the deployment of immigration policy to divide the Global North and South. This book illuminates how borders and boundaries are made, and made meaningful, through domination, resistance, and struggles over belonging.



Framing Taiwan's Indigenous courts as "boundary institutions," Upton shows how institutions designed to bridge Indigenous and non-Indigenous worlds both challenge and reproduce entrenched hierarchies and power dynamics. The book brings fresh methodological and conceptual tools to the study of legal pluralism, Indigenous courts, Indigenous peoples' rights, and the complex politics of Indigenous recognition in the Asia-Pacific region and beyond.




# **Life in Traffic**

Women, Plants, and Gold Along South America's Interoceanic Highway Ruth E. Goldstein

In the year 2000, the presidents of Brazil, Peru, and Bolivia agreed to construct the Interoceanic Highway as part of the Initiative for the Integration of the Regional Infrastructure of South America. Instead of bringing the promised economic benefits to the shared triple-frontier Amazonian region, the highway facilitated trade in extracted natural resources, as well as a traffic in women. Centering "traffic" as both an analytic and a method, Ruth E. Goldstein argues that projects like this 3,500-mile highway have deeply gendered effects, reorganizing political economies of sex, nature, kinship, and care. Life in Traffic underscores how markets for women, plants, and gold are not just intersecting phenomena but historically co-constituted economies. Amazonian extractive industries, too, have global ramifications for a warming planet: as rainforests disappear, so do the oxygen-creating, carbon-sequestering, and life-sustaining abilities of Earth, known to many as Mother.






Ganja is a popular name in Hindustani, Bengali, and other South Asian languages for intoxicating substances produced from the plant species Cannabis sativa L. Starting in the eighteenth century, British India's colonial administrators sought ways to systematically tax and govern how ganja circulated from the farms of peasant families in rural Bengal to pipes, plates, and cups elsewhere in the subcontinent. Ganja Matters follows the perpetual incongruity between regulatory efforts to pursue the plant through botanical observation, colonial reportage, and excise statistics and the leisurely, devotional, and creative pursuits of ganja among people. Utathya Chattopadhyaya offers a social history of ganja in a multispecies framework that reveals how the cannabis plant co-constituted histories of empire, gender, subalternity, and labor under British rule. Against the weight of the criminalization and "drug-ness" of cannabis, Chattopadhyaya puts the multidirectional and polysemic history of ganja as plant matter at the center of analysis.

# **Together We Fight**



In the mid-nineteenth century, fortune hunters turned their attention to Argentina, transforming it into a front line of an expanding West. While accounts of this period often emphasize impersonal economic flows, Emerging El Dorado demonstrates that this chase for wealth has a far more multifaceted, dynamic, and human history. In Argentina, it encouraged explosive growth across several fronts-financial, commercial, demographic, territorial. Capitalist routines of accumulation coexisted with get-rich-quick ventures, land grabs, and fraudulent schemes. Eduardo Elena's study profiles the promoters in Argentina and Europe who convinced others that this truly was a "rising country." At the same time, this book investigates the experiences of groups who helped propel expansion, such as migrant families and overseas investors, and those like mixed-race paisanos/as and Indigenous peoples who were deemed obstacles. By exploring these overlapping social worlds, Emerging El Dorado sheds new light on the roots of our present-day growth dilemmas.



Drawing on two years of ethnographic fieldwork, Nicholas Iacobelli examines how the prison's medical unit operates as a "ward of the state"—a site where the state's ideologies are reproduced when its obligation to care collides with its role to punish.


Incarcerated men are also wards of the state in the sense of being cast as its biological and financial property. This dynamic creates a complex system of dependence, refusal, and skepticism, as well as troubling ideas of what constitutes health and illness in prison. Despite this, the right to health care opens spaces for men to envision futures and to make both personal and structural appeals to justice—with both tragic and hopeful consequences.

Nicholas Iacobelli is Assistant Professor in the Division of General Internal Medicine at the University of Washington, where he cares for hospitalized patients and conducts anthropological research on the intersection of carcerality and health.

Even in the face of such exclusion, migrants sustain lives, labor, and care across borders. Enduring Illegality offers a critical account of how the state uses time as a mechanism of immigration control, structuring lives and inequality in ways that outlast any single policy or presidential administration.

# **Immunity on Trial**

Ethiopian Courts, Chinese Corporations, and Contestations over Sovereignty

Political and legal immunity are justified by the principle that certain social aims outweigh the value of imposing liability. To be exempt from the rules, however, is a privilege granted to or demanded by the powerful. The structural disparities that underpin immunity can turn it into an unjust prerogative, one that is inscribed by global inequalities.

Set against the backdrop of an extraordinary wave of litigation against Chinese corporations in Ethiopia, *Immunity on Trial* probes the question of immunity in everyday encounters steeped in highly asymmetrical power relations. Drawing on observations from the courthouse, interviews with litigants, judges, and court support staff, and the analysis of case files, Miriam Driessen demonstrates how immunity is debated and delegitimized, or affirmed, by those who fight, exact, grant, or weigh immunity. From the construction site to the police station, from the registrar's office into the courtroom, Driessen documents tussles over immunity, unravelling the politics of dignity on which they are founded.



It examines how, alongside constitutional changes, reforms in administrative law play an important role in polities with hybrid constitutions, shaping the architecture of government and constructing procedures to manage exchanges between government and citizens. Placing these reform processes in the longer-term context of postimperial history, it also shows how changes to legal systems acquire distinctive importance in societies with recent experiences of decolonization, uncertain sovereignty, and unstable patterns of citizenship.



# **Behind Ancient Bars**

Narratives of Incarceration in the Hebrew Bible

Hadar Aviram

In Behind Ancient Bars, law professor and rabbinical student Hadar Aviram challenges the conventional assumption that incarceration is an artifact of modernity by looking back to depictions of detention and confinement in the Hebrew Bible. Aviram takes readers on a journey through the Hebrew Bible's carceral landscape through creative rereadings of five stories: Joseph in Egypt, Esther in Persia, Daniel in Babylonia, Samson in Gaza, and Jeremiah in Jerusalem. Drawing on her experience as a leading voice against mass incarceration, she finds connections between antiquity and the contemporary understanding of incarceration that encompasses not just the prison itself but also pretrial/ immigration detention, bail, electronic monitoring, parole, and postrelease supervision. Infusing ancient biblical stories with fresh life through modern punishment theories, Aviram shows how incarceration has much to teach us about government, the experience of people in confinement, and the strength and resilience of the human spirit across millennia.



# The Precarious Past in Premodern Java

The practice of history in premodern Java was profoundly influenced by precarious conditions of textual production and preservation: fragile manuscripts perished in the tropical environment, archival records were scattered far afield, and historical memories faded over many generations. In this book, Wayan Jarrah Sastrawan examines how Javanese societies between the fifth and fifteenth centuries CE responded with distinctive strategies to record and transmit knowledge of the past. Drawing on sources in Javanese, Sanskrit, Malay, and related languages from the Indonesian archipelago, Sastrawan provides a detailed account of diverse forms of history-making in premodern Java, reconstructing a dynamic culture in which written and non-written modes of transmission coexisted and intersected. By situating these practices within broader discussions of global historiography, this book challenges modern assumptions about what counts as "history" and illuminates how societies have developed different ways of preserving and remembering the past.



# **Respectability on the Line**

Gender, Race, and Labor along British and Colonial Indian Railways

Mattie Armstrong-Price

Respectability on the Line offers a social and cultural history of railway labor in Britain and colonial India from the 1840s through World War I. The book treats the railway industry as a microcosm through which to study the history of capitalism in the liberal imperial era. Using company records, Mattie Armstrong-Price shows how executives shaped the domestic and working lives of higher-grade employees with an eye to cultivating their respectability. Meanwhile workers' writings reveal how railway towns provided opportunities for some employees to maintain non-heteronormative living arrangements. The book tracks these histories of everyday life while also outlining stories of early trade unionism. In Britain, railway unionists established benefit funds that mimicked company-sponsored provident funds, while in colonial India workers fought to gain access to company benefits on equal terms. This comparative study shows how industrial labor was made through conflict, subversion, and accommodation across an uneven imperial field.





# **Peripheral Citizenship**

How is citizenship constructed from the margins? Peripheral Citizenship examines this question by placing the urban periphery of South America's most populous city, São Paulo, at the center of processes that transformed twentieth-century Latin America: rural-urban migration and rapid urbanization, the advent of liberation theology, and the rise and fall of military dictatorships. Drawing on oral histories and grassroots archives, Daniel McDonald traces the emergence of a remarkable bottom-up rights campaign through the lives of rural migrants, progressive clergy, and allied activists in São Paulo during the military dictatorship (1964-1985) and the subsequent democratic transition. McDonald unveils how popular movements aligned with the progressive Catholic Church and leftist political parties forged a vision of citizenship that combined rights grounded in everyday life with innovative forms of participatory democracy. In the process, they reshaped the city, the Church, and the nation from the periphery.




The Future in Their Hands is a deep history of the politics of foreign education in Mexico, where many influential figures have European or US degrees. Reconstructing the history of student mobility from the late nineteenth to the late twentieth century, Rachel Grace Newman unveils the social hierarchies, political languages, and institutional mechanisms that created Mexico's foreign-educated elite. Study abroad began as a private phenomenon for young elites to acquire specific forms of knowledge and to preserve their status. But, as Newman shows, after the 1910 revolution, elites gradually convinced the Mexican state, under the guise of modernizing the nation, to underwrite their ambitions with merit-based scholarships. Student mobility naturalized the expectation that Mexico's sovereignty and development required knowledge from somewhere else. For historians of Mexico and other countries with foreign-educated elites, this book reveals the subtle, insidious processes by which states reinforce privilege through education policy.

Muslim Merchants and the Business of Empire in the Eighteenth Century Zoe Griffith

Egypt's Mediterranean explores the intersections of commerce and statecraft in the eighteenth-century Ottoman Empire through the lives of overlooked intermediaries who lived and worked on Egypt's Mediterranean coast. Egypt's port cities mediated the geographic distance and economic scales between the province's agricultural landscape, its Red Sea connections, its hegemonic capital city, and its position within the wider Ottoman realm, while Ottoman Muslim merchants acted as linchpins of imperial governance in Egypt, mediating the state's access to Egyptian wealth. Drawing on Arabic, Ottoman, and French sources, Egypt's Mediterranean foregrounds the role of Muslims and Islamic law in Mediterranean history, decentering European capital and actors in an interconnected story of imperial realignment and changing fortunes on the eve of modernity.

# **Borderless Painting as Borderless Art**

Antonio Dias between Brazil and Europe Sérgio B. Martins

The artwork of Antonio Dias (1944–2018) uniquely captures the interwoven histories of Brazilian postwar realism and of European conceptualism in the 1960s and 1970s. By tracking Dias's evershifting works and circulation as he moved from Rio de Janeiro to Paris, and then to Milan, *Borderless Painting as Borderless Art* provides the first in-depth study of the artist.

Sérgio B. Martins uses Dias's trajectory as a lens to explore different approaches to avant-gardism and its crisis in Brazil, France, and northern Italy, weaving in the perspectives of figures such as Hélio Oiticica, Harald Szeemann, Pierre Restany, Giulio Paolini, and Tommaso Trini, as well as the Fluxus movement. The book ultimately argues that Dias pitted his formation in a semi-peripheral avant-garde against a post-avant-gardist milieu where commodity culture and market relations were far more pervasive and determinant vis-à-vis the arts scene.



He shows how these artists confront these social and state problems through innovative art projects that foster resistance and solidarity among Mexico's diverse communities, and how their works collectively reimagine a more hopeful and egalitarian future for Mexico.





Each chapter attends to a distinctive visual ecology fostered by institutions and individuals committed to desegregation to varying degrees, including the nationwide public art initiatives of the New Deal, the imagery and cultural programs of the multiracial Popular Front, graphics produced for CIO-member labor unions, Jacob Lawrence's war paintings and other visual propaganda of the armed forces, and the struggle of New York abstract painters of African descent to navigate the criticism, museums, and markets of the mainstream art world. Together, they explore the divergent approaches to conceptualizing and implementing racial integration along the liberal-radical axis.





Artists' Television in New York City Benjamin Olin

New York City's downtown scene of the 1970s and 1980s is synonymous with underground film, video, and performance art. Many of the artists who would come to define this period also dabbled in public access cable television—which was then a very new technology—as host, producer, guest, or studio audience member. Drawing on archival research and personal interviews, this book, the first full-length study of this vibrant body of work, explores how poets, painters, and filmmakers produced talk shows and soap operas that warped the heteronormative conventions of prime-time fare. Working outside the established art world, artists screened their shows in lofts and nightclubs and aired them live on Manhattan Cable, provoking frequent tabloid censure. Affirming the importance of cable television to the downtown art scene, Underground Networks recovers an essential strand of avant-garde screen culture and a user-driven media ecology with uncanny contemporary resonance.







Sufism, for many of its medieval followers, was the "religion of love." God was the beloved and the Sufis, his lovers. To become a Sufi meant to become a lover. In this book, Matthew Thomas Miller pursues the radical analytical implication of this amatory metaphysics: If God and his divine secrets can only truly be known in their fullest through the experience of love, then we must analyze how it feels to be a Sufi on the Path of Love. Leveraging insights from the history of emotions and affect theory, this study examines key Sufi ritual practices and poetics to show the central role that affect plays in the process of constructing Sufi subjectivity and knowledge production. It explores the felt dimension of medieval Sufism and why feeling—especially, like a lover—was so important for coming to truly know God and his divine secrets.
