From Our New Executive Director

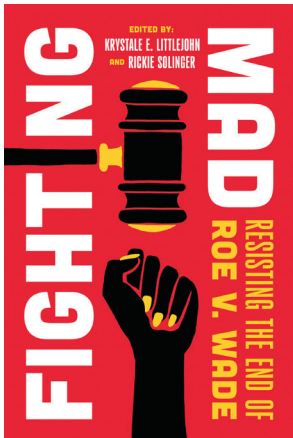
As the relatively new executive director of the University of California Press, I am delighted to share this annual report with you. The report highlights some of the Press's accomplishments during the 2023–24 fiscal year, as well as our vision for the future. The creation of this annual report itself is a bit of a milestone. As with so much of what we do, it is the culmi-

nation of a highly collaborative, team-driven approach. In these pages, you will find a wealth of information about the Press's innovative and impactful publishing programs and new, exciting initiatives aimed at cementing broader partnerships both within and outside the University of California.

After 26 years serving UC Press in various capacities, I have been honored to take over the leadership of this amazing organization. In the role of executive director, I inherit the legacy of an impressive publishing program that has been a vital part of the University of California for over 130 years. As I have met with my Press colleagues over the last year to hear their ideas about how to advance the Press into a transformative new era of publishing, one theme has surfaced again and again: staying true to our mission. This mission—publishing books and journals that shift paradigms in the arts, sciences, humanities, and social sciences, with a focus on social justice—is the north star for our programs. This year, it led to groundbreaking new books such as Krystale E. Littlejohn and Rickie Solinger's collection *Fighting Mad: Resisting the End of Roe v. Wade* and Matthew D. Morrison's *Blacksound: Making Race and Popular Music in the United States*.

On the journals side of the house, we launched a new collaboration with the UCLA Chicano Studies Research Center to publish their long-running journal *Aztlán: A Journal of Chicano Studies*, starting in January. We hope this will lead to larger collaborations with the UC campuses as we launch a new publishing services venture.

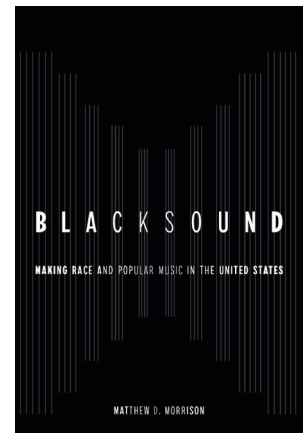
Beyond our publishing programs, the Press is renewing its efforts to engage and cultivate a community of philanthropic supporters through



the UC Press Foundation. The chair of our Foundation Board of Trustees, Michelle Ciccarelli Lerach, along with the other trustees, has brought dedication and energy to the Press's fundraising efforts in support of our distinctive publishing programs. This year, the Foundation sponsored author events on both the Santa Barbara campus and in San Diego as the Press sought to broaden its fundraising network. We also welcomed a new director, Amanda Todd, to the UC Press Foundation, and a new development officer, Nada Shalaby, to our fundraising team. The generous support of donors is required in order to maintain our commitment to advancing our independent, nonprofit, progressive publishing mission. This support also helps undergird our commitment to innovative programs such as our FirstGen program, which seeks to cultivate and support the work of first-generation scholars—those who are the first in their families to receive a college degree.

I am honored to work alongside a strong and diverse team of dedicated professionals who are critical to advancing the Press into a new era. We know that transformative trends such as a shift to open access publishing models and an increased reliance on tools driven by artificial intelligence will become the norm. We collectively will need to position ourselves for this future while maintaining our commitment to publishing top-quality scholarship, pursuing an equity-focused agenda, and growing and expanding our output. This is a tall order—but if any university press is up to the challenge, it is the University of California Press. I thank all of our authors, journal editors, donors, board members, booksellers, staff members, and the many others who contribute to the success of our programs for your continued partnership and support.

PUBLISHING KNOW-HOW AND INNOVATION

Sharing Publishing Expertise

UC Press staff regularly engage with faculty and staff on all 10 UC campuses and at colleges and universities throughout the country to help them meet their publishing objectives. In the past year, UC Press staff presented valuable information on topics including revising a dissertation into a first book, choosing the right journal for an article, building a public platform, and making sense of open access publishing. These events ranged in size and scope from a major humanities publishing symposium, co-organized with the UC Humanities Research Institute, to smaller seminars for graduate students and early-career researchers.

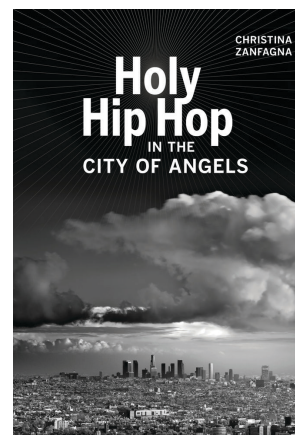

Open Access — Providing Equitable Access

Beyond sharing our expertise with researchers far and wide, UC Press as a nonprofit, mission-driven publisher shares UC's public focus and emphasis on acting as an engine of social mobility and social change. This emphasis lies not only at the heart of what we publish but also in how we publish it. Providing equitable access to scholarly publications continues to motivate our expansion of open access publishing options for our authors. Since the launch of our open access programs in 2015, UC Press has published over 175 books and hundreds of scholarly journal articles in electronic formats that are free to read. UC Press's innovative cost-sharing model for open access books is a collaboration among the Press, the institutions of its authors, and university libraries. With the same high standards for selection, peer review, production, and marketing as the Press's traditional programs, this transformative open access book publishing model now constitutes nearly 20 percent of the Press's scholarly book output. We have also been at the forefront of providing open access publishing options for our journal authors: we provide options to publish in fully OA journals and also OA publishing options in subscription journals.

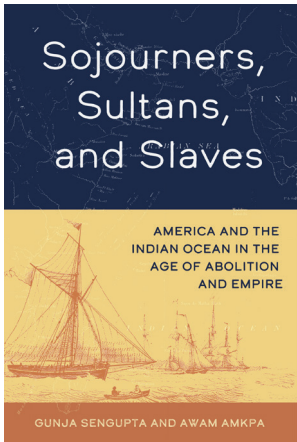
Book Awards

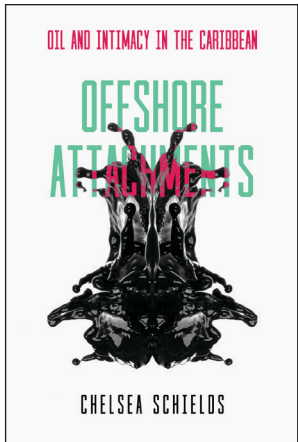
Journal Awards

The *Journal of Autoethnography (JoAE)* was named Best New Journal in 2023 by the Council of Editors of Learned Journals, marking the third consecutive year a UC Press title has received this esteemed honor. Previous winners include *Global Perspectives* and *Latin American and Latinx Visual Culture*. Additionally, *JoAE* garnered two awards from the National Communication Association: the Ethnography Division’s Best Journal Article Award and the GLBTQ Studies Division’s Monograph of the Year Award.

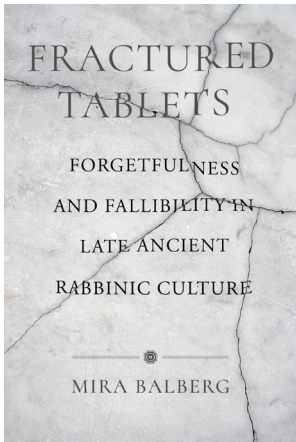

UC PRESS PUBLISHES paradigm-shifting books in the arts, sciences, humanities, and social sciences, with a focus on social justice.

Interdisciplinarity is a watchword for UC Press. We publish award-winning books across the humanities, social sciences, and sciences, pushing these disciplines to cross traditional boundaries, be more inclusive and expansive, and question their own premises. We are interested in issues that are too big for one discipline to address and thus we publish in areas that cut across disciplines—race, ethnicity, migration, gender and sexuality, inequality, environmental studies, colonialism and resistance, technology and society, labor, and so on. These kinds of topics need economists to talk with ecologists, sociologists to talk with policy makers, and our lists are an ideal place to facilitate such conversations among scholars and among disciplines.

We look for voices and ideas that will shape the academy and the world in the years to come—we mix new voices with more experienced ones and we actively seek out underrepresented scholars. We publish authors who aim to have an impact with their work, many of whom identify as scholar-activists and bring academic research and theory to life with vivid ethnography or storytelling.

UC Press publishes scholarly books, crossover trade books for the general public, and coursebooks for the classroom. In this way, our publishing mirrors the mission of the University of California as a whole: supporting research with specialized books; teaching, by getting our books into the classroom; and public service, by translating scholarly knowledge for a broader audience.

We are passionate about being a key player in sharing the most important values of our state and university system around the world.

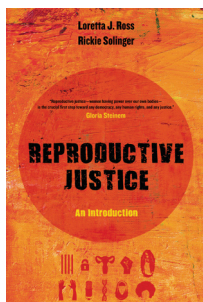
New Series — Co-Opting AI

Launched in 2024, Co-Opting AI is a new series of compact books for readers to better understand the social dimension of artificial intelligence. Instead of playing into the hype around AI, these short books ask big questions and bring together forward-thinking scholars, writers, journalists, activists, and others to consider how we can reclaim the stories we tell about technology and our lives. They address key issues such as inequality and in/justice, the future of work, democracy and governance, the climate emergency, the economy, education, health, and the physical spaces we inhabit.

Launched in 2017 with the publication of *Reproductive Justice: An Introduction*, by Loretta J. Ross and Rickie Solinger, the series Reproductive Justice: A New Vision for the 21st Century published its 10th book this past year. The series has covered such crucial topics as the history of sterilization of minorities, the unfair burden of contraception on women, the abortion pill, youth sexual health, and the movement mobilizing to resist the end of *Roe v. Wade*.



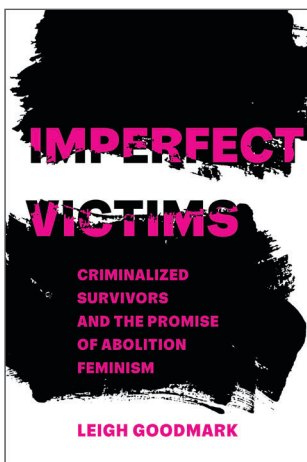
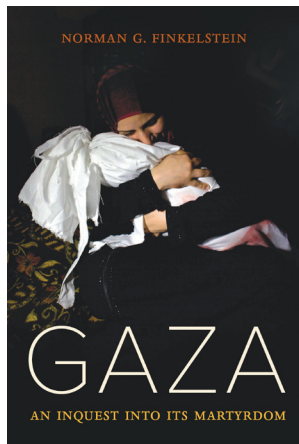
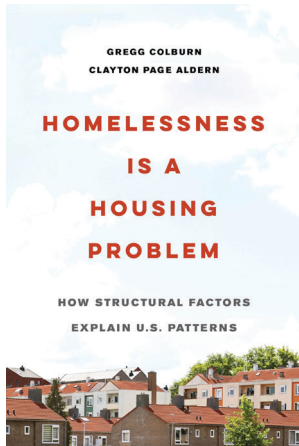

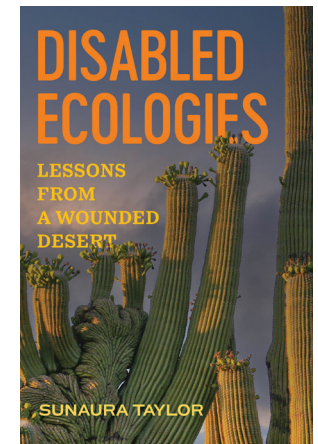
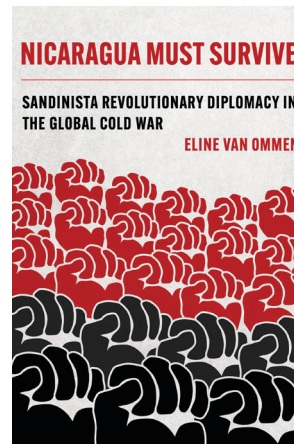
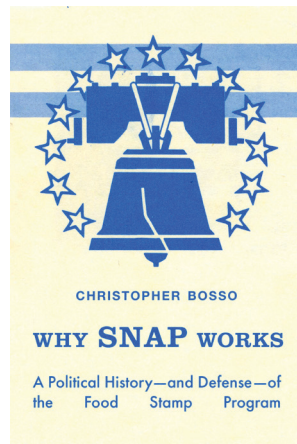
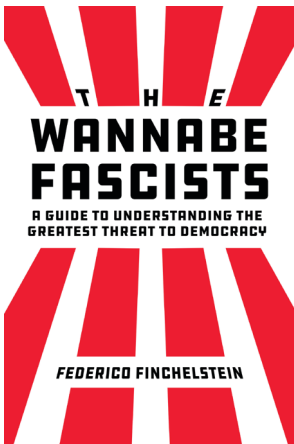
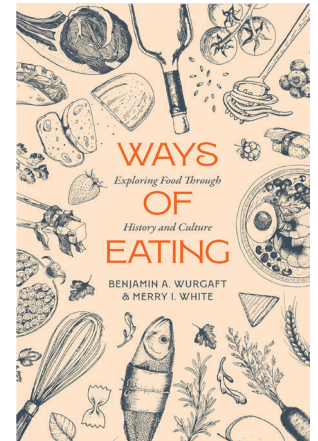
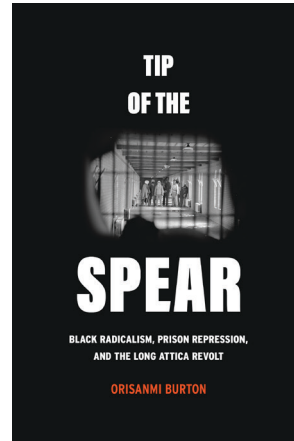
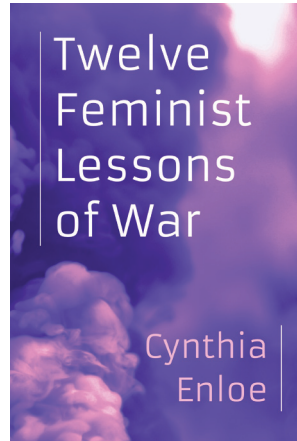
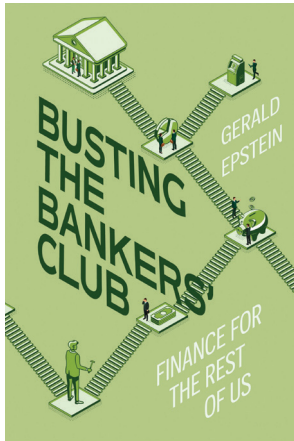


Books Making a Difference

We believe that books make a difference. We see the impact of our publishing program every day as our authors contribute knowledge and original perspectives to the most important public and scholarly conversations of our time. Here are just a few examples:

- *Homelessness Is a Housing Problem: How Structural Factors Explain U.S. Patterns*, by Gregg Colburn and Clayton Page Aldern, has had widespread impact. To name just a few examples: When soliciting applications for new projects to provide permanent housing for people experiencing homelessness, the City of Portland now cites this work to justify its permanent housing strategy. The Pew Charitable Trusts leveraged the authors' research in a recent argument to the Montana legislature on housing shortages. The Victoria Transport Policy Institute cites Colburn and Aldern's work in advocating for increasing affordable housing in accessible neighborhoods.
- In 2018, UC Press published *Gaza: An Inquest into Its Martyrdom*, by Norman G. Finkelstein. In the past year, Finkelstein has again become one of the most sought-after global spokespeople on Israel and Gaza, and his book has sold more than 20,000 copies.
- Leigh Goodmark, author of *Imperfect Victims: Criminalized Survivors and the Promise of Abolition Feminism*, sent a copy of her book to a woman who was incarcerated after her abusive partner murdered her child. She told Goodmark that, since being separated from her remaining children and beginning a 15-year prison sentence, she'd had nothing left to live for until she read *Imperfect Victims* and realized that her own victimization was not her fault. She penned a piece in [*The Appeal*](#), writing that "Mother's Day reminds me to help end intimate partner violence by speaking up about a subject that is often considered taboo, raising awareness about the collateral damages that can occur from intimate partner abuse, and letting women know they are not alone."

JOURNALS

UC PRESS HAS LONG BEEN a highly respected publisher of scholarly journals, and our journals program serves as an integral part of our overall publishing program. We publish 40 journals in a wide variety of subject areas, many in conjunction with esteemed scholarly organizations. We work collaboratively with engaged and committed editorial offices and publishing partners to publish high-quality scholarship from a large, diverse body of contributors. This past year we published more than 1,900 articles, essays, book reviews, and other journal content representing the work of thousands of authors, editors, and peer reviewers.

Usage and Reach

Over the past year, our journals content was accessed more than three million times by readers, researchers, and scholars around the world. The most accessed article online in calendar year 2023 was “Sample Size Justification,” by Daniël Lakens, published in *Collabra: Psychology*. Other highly accessed articles include:

Joining the Program



Open Access Journals

Open access remains an important part of our journals program, and we have been on the forefront of providing OA publishing options. We provide options to publish in fully OA journals as well as OA publishing options in several subscription journals. In the past year, over 13 percent of our journals content was published open access. UC Press publishes four active open access journals:

- *Advances in Global Health*
- *Collabra: Psychology*
- *Elementa: Science of the Anthropocene*
- *Media+Environment*

In addition to these open access journals, both *Global Perspectives* and *Communist and Post-Communist Studies* now provide authors an open access option for published articles.

Impact

UC Press journals are high quality and have high impact.

80% of our journals are indexed in Scopus.

63% of our journals have impact factors.

64% of our ranked journals experienced an increase in their 2023 impact factors.

Current History saw the biggest impact factor increase, from 1.3 to 2.4.

Elementa: Science of the Anthropocene enjoys the highest impact factor of our program, at 4.7.

Departures in Critical Qualitative Research received its first impact factor.

FIRSTGEN PROGRAM



FIRSTGEN

LAUNCHED IN 2021, the FirstGen program serves UC Press's mission to publish and support a diverse community of scholars. As a nonprofit, progressive publisher within the UC system, UC Press builds on the University of California's own FirstGen initiative to support students who are first in their family to receive a college degree and expands efforts to improve equity in scholarly publishing.

Research has shown that supporting first-generation students is critical to increasing educational equity: while first-gen students make up as much as one-third of undergraduate students, they confront intersecting inequalities across race, income, immigration status, and more. This affects how many first-gen students continue on to get advanced degrees and become scholars, authors, and faculty. As part of the discovery phase of the program, we launched a survey and conducted interviews with first-gen scholars about their book publishing experiences. Research Report: The First-Gen Scholar Publishing Experience is the summary of our findings and includes key statistics, commonly cited challenges, and recommendations for better supporting these scholars through the publishing process.

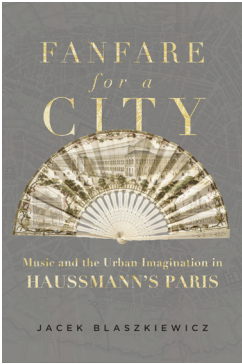
UC Press’s FirstGen program has two major aims: to provide augmented support to first-gen UC Press authors and to provide ongoing resources to the larger first-gen scholarly community. The press provides outright grants to all first-gen book authors, builds community through workshops, and provides access to resources to help write, publish, and market scholarship. UC Press also contributes to the larger first-gen community by facilitating workshops, webinars, and presentations; collaborating with institutions and professional organizations; and providing access to an aggregate archive of resources aimed at writers and scholars. Through these efforts, we hope to more effectively integrate the work of first-gen scholars into our publishing program and into the discourses of scholarly communication at large.

The FirstGen program has been establishing key partnerships across the UC system, including with the President’s Postdoctoral Fellowship Program, the UC Chicanx/Latinx Leadership Summit, and the UC Systemwide FirstGen Coalition.

We believe in the potential for scholarship to fundamentally change how people think, lead, and live. Publishing works by first-gen scholars ensures that these distinct voices are included in the conversations that matter.

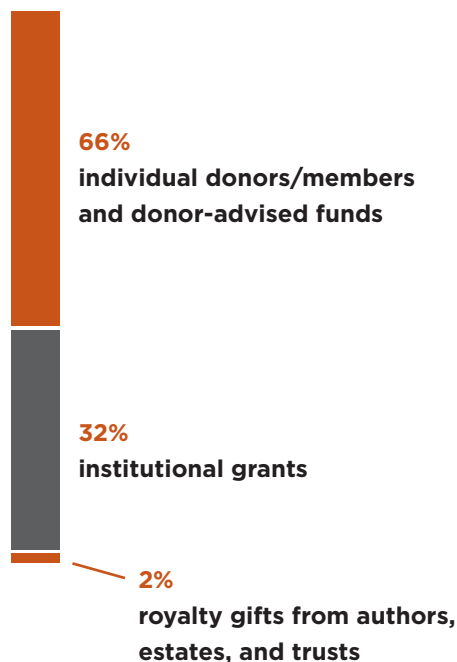

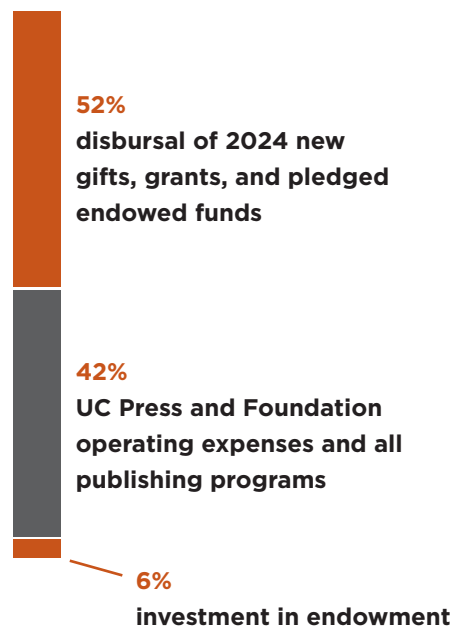
